THIS AMENDMENT TO AGREEMENT FOR EDUCATIONAL RELEASE TIME AND SERVICE COMMITMENT is made and entered into as of the day of
2005, by and between The Johns Hopkins Health System Corporation ("JHHS"), a not-for-profit Maryland corporation, and ("Participant"), an individual.
RECITALS
WHEREAS, JHHS and entered into an Agreement for Educational Release Time and Service Commitment dated (the "Agreement"); and
WHEREAS , the parties wish to amend the Agreement to specify Participant's time commitment to his/her current Home Affiliate's department.
NOW, THEREFORE , in consideration of the mutual covenants and conditions hereinafter set forth, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:
1. <u>Definitions</u> . Unless otherwise set forth in this Amendment, all capitalized terms shall have the meaning as set forth in the Agreement.
