Important Don'ts:

- <u>Do not sell</u> your securities and forward the proceeds to Suburban Hospital. This will then be considered a cash donation and you may be required to pay capital gains tax on the gift.
- If your securities have <u>depreciated in value</u> (generated a loss since their purchase) you may wish to sell and donate the proceeds. Contact your tax advisor regarding the advisability of your approach.
- As a general rule, it is not suggested to donate stock that you have held for less than one year.
